



Memorandum of Understanding ADDENDUM

Angelo State – Plainview ISD Academic Off-Site Dual Credit

The purpose of the addendum to the Academic Off-Site Dual Credit Memorandum of Understanding (MOU) is to outline procedures for receiving payment of tuition and fees for students taking dual credit courses through Angelo State University, hereinafter referred to as "ASU", at Plainview Collegiate High School, part of the Plainview Independent School District, hereinafter referred to as "PISD".

Tuition and Fees:

- A. Each student will be charged the ASU dual credit tuition and fees rate.
- B. PISD may provide students with stipends to cover courses based on eligibility determined by the district.
- C. ASU will invoice PISD the entire amount for the balance of all students taking dual credit courses at Plainview Collegiate High School per semester following the 20th class day of the semester. Payment for the entire balance should be received by ASU within 30 days of the billing date.
- D. PISD will be responsible for collecting payment from students who will not receive a stipend or have a balance remaining after the stipend is applied. Students should make payment directly to PISD.
- E. If a student drops a course, the refund will be calculated based on the refund schedule in the ASU catalog, with the maximum being the amount PISD paid. Refunds will be sent to PISD.

Effective Date:

This MOU becomes effective upon the date of the last approving signature and will remain in effect for one year. Thereafter, this MOU shall automatically renew on an annual basis for up to four years unless thirty (30) days written notice of intent to terminate the MOU is given by either party.

Termination:

Either party may terminate this MOU at any time, with or without cause, by giving the other party thirty (30) days written notice of its intent to terminate the MOU. However, students assigned at PISD when termination of notice is given shall be permitted to complete their current courses at either ASU or PISD's option.

This agreement shall be governed and enforced in accordance with laws of the State of Texas. Venue will be located in Tom Green County, Texas with dual credit courses taking place in Hale County.

Independent Contractor Status:


